Polysure F0115LM is a 1-hexene comonomer based Linear Low-Density Polyethylene, produced by Gas Phase – UNIPOL™ PE technology, using Metallocene Catalyst and primarily suitable for Multilayer Blown Film Extrusion Process. This grade does not contain Slip & Anti-block additives. Film produced with F0115LM offers smooth processing & superior drawdown characteristics. Film also has outstanding cold temperature, toughness, impact strength and puncture, heat seal strength and optical properties.

### Processing Guidelines:

- Barrel Temperature : 175 - 220°C
- Blow Up Ratio : 2 - 3
- Die Gap : 1.8 - 2.5 mm

### Storage & Handling:

Bags should be stored in dry & dust free environment at temperature below 50°C and Prevent from direct exposure to sunlight & heat to avoid quality deterioration.

This grade meets the requirements of IS 7328:2020 - Specification for Polyethylene Material for Moulding and Extrusion.

### Regulatory Requirements:

F0115LM to be manufactured complying the requirements specified in IS 10146 on "Specification for Polyethylene for its safe in contact with Foodstuff, Pharmaceutical & Drinking water". Furthermore, the Additives added in this grade formulation compiles to the "Positive list of constituents for Polypropylene, Polyethylene and their Copolymers for its safe use in contact with Foodstuffs & Pharmaceuticals' as laid down under IS 16738:2018. In general, the additives & constituents used in the grade are in line with requirements laid down under FDA: CFR Title 21,177.1520, Olefin Polymers.
